## WHAT TO EXPECT FROM YOUR INSPECTION

- 1. **Purpose:** The purpose of the inspection is to attempt to detect the presence of home defects by performing a visual inspection of the property and it is a snapshot of the condition of the home today the time of inspection. This report will not address environmental concerns or provide cost estimates.
- 2. **Scope:** The scope of the inspection is limited to the readily accessible areas of the property and is based on the condition of the property at the precise time and date of inspection. Things can and do change and a home inspection will not stop these changes from occuring. Furthermore, as such, the report is not a guarantee or warranty that hidden defects do or do not exist. As a courtesy **360 INSPECTION SERVICES** may point out conditions that contribute to possible home problems/defects but such comments are not part of the final report.
- 3. **Report:** The **CLIENT** will be provided with a written report within 24-hours of **360 INSPECTION SERVICES**' visual observations. **360 INSPECTION SERVICES** is not able to determine all deficiencies from visual observations alone. Some deficiencies may go unnoted in the report and the client accepts this. The report is not intended to comply with any legal obligations to disclosure. The Home Inspector is a Generalist, not a specialist in all disciplines.
- 4. **Exclusivity:** The report is intended for the sole, confidential and exclusive use and benefit of the **CLIENT** and **360 INSPECTION SERVICES** has no obligation or duty to any other party. **360 INSPECTION SERVICES** accepts no responsibility for use by third parties. There are no third party beneficiaries to this agreement. This Agreement is not transferable or assignable. Notwithstanding the foregoing, the **CLIENT** understands that **360 INSPECTION SERVICES** may notify the homeowner, occupant, or appropriate public agency of any condition(s) discovered that may pose a safety or health concern. Inspection is not Building code or By-Law compliance.
- 5. **Limitation of Liability:** It is understood **360 INSPECTION SERVICES** and its associates are not insurers and that the inspection report shall not be construed as a guarantee or warranty of any kind. The **CLIENT** agrees to hold **360 INSPECTION SERVICES** and their respective officers, agents and employees harmless from and against any and all liabilities, demands, claims, and expenses incident thereto for injuries to persons and for loss of, damage to, destruction of property, cost of repairing or replacing, or consequential damage arising out of or in connection with this inspection.
- 6. **Major Problems:** The purpose of the Home Inspection is to find and indentify visible existing major problems apparent on the visual inspection of the home. Home Inspectors can greatly reduce the risk of a home purchase but it is impossible to totally Eliminate the Risk.
- 7. **Litigation:** The parties agree that any litigation arising out of this Agreement shall be filed only in the Court having jurisdiction in the Province in which **360 INSPECTION SERVICES** has its principal place of business. If **360 INSPECTION SERVICES** is the substantially prevailing party in such litigation, the **CLIENT** shall pay all legal costs, expenses and attorney's fees of **360 INSPECTION SERVICES** in defending said claims.
